What is NGN?

- NGN is a 501(c)12 cooperative (just like EMCs)
- Received \$33M in ARRA/BTOP funds to build fiber connectivity in N. Ga., with \$2.5M from OneGeorgia, \$8M in-kind & matching locally
- Vision is to bring tens of thousands of NG families & businesses to the right side of the 'digital divide'






What is NGN (cont.)


- Focus is Core 260-mile ring
- Additional middle-mile fiber will connect "anchor" institutions & areas
- Last-mile fiber will serve
 8000+ businesses and home customers in mostly rural, unserved areas





What is "Fiber"?

- Fiber Optic network cable is composed of pure glass/silica strands about the width of a human hair (sample 96-strand)
- Carries laser light signals at speeds currently at 10Gbps per wavelength
- Some fiber can carry hundreds of 'colors' per pair








Why do we need NGN Fiber?

Figure 21 Regional Commission Service Sorted by Served Percentage






Why Fiber? (cont.)

Actual Download

Speeds Necessary to Run Today's Internet Concurrent Applications (Mbps) applications consume more bandwidth - the FCC now classifies "broadband" as a minimum of 4Mbps download and 1Mbps upload speed

Why Fiber? (cont.)

- Copper infrastructure cannot keep pace with the bandwidth needs of 21st century consumers
- Fiber optics can carry hundreds or thousands of times the capacity, at lower cost & with easier upgrades
- NGN fiber will carry 100Gbps on day 1
- 3.6Tb and higher capacity on demand





Fiber vs. DSL/Cable

DSL

If the average DSL connection in our area (around 1.5Mbps) was equal to the height of a can of Coke...








Fiber vs. DSL/Cable

 1Gbps Fiber (like the University's) would stretch almost 270 ft high (about the height of the Capitol Dome in Atlanta)

1Gbps Fiber








Fiber vs. DSL/Cable

 3.6 Terabits (current NGN Fiber capacity per pair of strands) would span over 180 miles – about the orbit of the International Space Station, or 2.4M cans of Coke high!

What's in it for me?

- Near-term: 8,000 customers in the eight county area will have fiber-to-thehome/business available by the end of 2012
- Mid-term: More options, competition, better prices
- Long-term: High-tech jobs, high-paying, low environmental impact industry





What's in it for Dawson County?

- Four Dawson schools already set for fiber, another 4 within the next 6 months
- New route additions in Dawson to reach desired economic development sites (incl. Charlie's office) just approved
- Distance learning opportunities, industrial & high-tech ultra-broadband

When is it coming?

- The core 260-mile backbone loop is on schedule for completion in November 2011 (approx. 75% complete as of July 14, 2011)
- An additional 700+ miles of middle-mile and fiber-to-the-home will be in place by November 2012
